1. DECLARATION OF TRUST:

The author hereby declares and affirms that a sum of Rs.1,000/- has been declared on the trust as its corpus for carrying out the objectives of the trust.

2. NAME OF THE TRUST:

3. OFFICE OF THE TRUST:

The principal office of the Trust shall be for the time being at 64, West Bazaar, Sendamangalam, Namakkal District. 4. OBJECTIVES OF THE TRUST:

The Trust has been constituted for and shall carry out all or any one of the following objects for the welfare of the General Public irrespective of caste, creed, sex or religion:

- e) To publish periodicals, books, journals, and news letters etc., devoted to the promotion or furtherance of the above mentioned objectives.

- f) To assist or to take assistance from to interact with any institution formed for charitable purposes with similar objects.
- g) To assist any institution formed for charitable purpose which are recognised U/S. 80G of Income-tax Act, 1961.
- h) to do or cause to be done all such lawful things as are in accordance with the spirit and principles of the trust (or) which are conducive to the attainment and pursuit of the aims and objects of the trust.
- i) To provide facilities for conducting all types of yogas, meditation and other related subjects.
- j) To start and run museums and libraries.
- k) To start and run training institutions on teaching, music, games, and sports etc.,
- l) To start and run child-care centres and home for aged.

Each of the above objects shall be independent of the other and none of the above objects shall involve the carrying on any business, trade or any activity for profits.

It is further declared that the trust shall not carry on any business, trading activity or activities or with the intention of earning a profit. The aforesaid objects of charity shall be provided to the beneficiaries without distinction of caste, creed, colour, sex or religion. It is further declared that no activities of the trust will be carried out outside India.

5. TRUST FUND:

- 1) The sum of Rs.1,000/- (Rupees One thousand only) declared by the author of the trust forms part of the corpus of the trust.

- h) The Managing Trustee shall have overall power of superintendence over the affairs of the trust and shall have in particular the power to operate the bank accounts, borrow monies and getting grants from the state and Central Governments for the trust and carry out the objects of the trust.

- j) The Board of Trustee may Appoint if required one of their members as secretary and treasurer if required once in three years from among themselves by election.
- k) One third of the trustees shall retire once in three years and the retiring trustees shall be eligible for re-election. It shall, however, be open to any one of the trustees to retire from the office of the trustees by giving 3 months notice to the trustees of their intention to retire.

Any trustee may be removed from the office of the trust by resolution of the Board of Trustees passed by a 2/3rds majority.

- i) On being found guilty of misconduct, breach of trust, or activities prejudicial to the interests of the trust;
- ii) On being convicted in any criminal offence and sentenced by a court of competent jurisdiction;
- iii) On declared insolvent; and
- iv) If any trustee becomes permanently sick and bed-ridden not being able to attend to the affairs of the trust or he suffers from a permanent sickness or a personal disability which renders him incapable of attending to the affairs of the trust or meetings of the Board of trustees;
- v) Any trustee retiring, resigning or being removed from office shall continue to be liable to the trust for all the acts during the period for which he was a trustee.

7. PROCEEDINGS OF THE TRUST:

- a) The Board of Trustees shall meet atleast once in six months with a clear notice of seven days caused by the Secretary, of the trust or by trustee incharge or Executive Trustee or by the Managing Trustee as the case may be.

- d) The resolution in writing signed by the majority of the trustees shall be as valid and effectual as if it had been passed at the meeting of the trustees duly called and constituted.
- e) The quorum for holding the Trustees Meeting shall be Two.
- f) The decisions taken by the majority of the trustees shall be valid and effectual and shall be carried out.

- vi) To sell or otherwise dispose of any property or assets of the trust, movable or immovable for the purpose of reimbursement of the proceeds in such other form of

- xi) To appear before the Registrar of Assurance, Sub-Registrars or Assurances or any other officials appointed for registration of deeds, assurances, documents and other instruments, to execute or be present and admit executions and register or cause to be registered, any deed, assurances, documents etc., in which the trust is interested or involved.

10. ACCOUNTS:

The trust shall maintain regular accounts of all its transactions showing clearly the receipts and expenditure. All the expenses of the trust shall be properly vouched and audited by a Chartered Accountant every year. The accounts of the trust shall be approved by the Board of Trustees every year.

11. STATUTORY OBLIGATIONS:

- a) The Trustees shall comply with all the relevant statutory Obligations.

No investment shall be made by the trust in any security or in any manner which shall render it ineligible for exemption under the provisions of the Income-Tax Act in respect of donations received by it or in respect of Income earned by it under the Provisions of Sec.11 or other provisions of the Income-Tax Act.
- c) It is specifically stated that the trust shall not make any investment or enter into any transaction with the authority of the trust or other funds which shall render the trust ineligible for exemption under the provisions of the Income-Tax Act, or bring it within the

- d) The funds of the trust shall not be distributed among or appropriated by the trustees for their own benefit.
- e) It shall be the endeavour of the trust that the benefits and objectives of the trust shall be for the benefit of the public at large irrespective of sex, caste, creed and religion.
